# **GS1 DataMatrix 2027 Sunrise** for Healthcare

Aims to provide education, awareness, and support on the GS1 DataMatrix capabilities that can help industry embrace the 2027 2D Sunrise for regulated healthcare

#### **GS1** Healthcare US RFID Workgroup

Identifies opportunities for manufacturers, distributors, wholesalers, and providers/dispensers to implement RFID encoding practices and ensures encoding standardization across the supply chain

### **Rx Secure Supply Chain Workgroup**

Collaborates across a diverse mix of pharmaceutical manufacturers, wholesalers, dispensers, solution providers, and associations preparing to meet the requirements of interoperability for item-level serialization defined in the U.S. FDA Drug Supply Chain Security Act (DSCSA)
